VIRTUAL INTERVIEW

Applications are invited from the eligible candidates for the post of 'Junior Research Fellow (JRF)' in a DST funded project entitled "Non-chemical management of stored-grain moths using flexible light-trap" at ICAR-Central Institute of Post-Harvest Engineering and Technology (CIPHET), Ludhiana, Punjab. The appointments will be purely temporary under contractual and co-terminus basis, following the prescribed procedure for 'six months' or till the completion date of the project. The appointments may be terminated at any time without notice or assigning any reason thereof.

All the original documents will be verified during interview and at the time of joining, if selected.

- ii) Age: The upper age limit will be 35 years (*No. 3 as per DST O.M. SR/S9/Z-05/2019 (sr. no.3) dated 10.07.2020*). Age relaxation in the case of SC/ST/OBC & other exempted categories of candidates as per rules.
- iii) The screening test may be conducted, depending on number of candidates. The decision will be taken by selection committee.
- iv) Only shortlisted candidates based on their academic excellence and research experience will be call for interview.
- v) The reporting time for online interview will be communicated in advance and the candidate should adhere to the instructions.
- vi) Mobile number (preferably WhatsApp) and E-mail ID must be entered in the prescribed application form, therefore, the applicant must have a valid operative email and mobile number. All shortlisted candidates are requested to download Zoom/Skype/WhatsApp and register before scheduled time for online interview.
- vii) Place of work will be ICAR-CIPHET, Ludhiana and involves working/ travelling in selected places of our country for activities taken under the project.
- viii) No TA / DA will be paid for appearing in interview/ joining.
- ix) HRA (admissible) will be given only if, accommodation is not provided at the institute.
- x) The services of selected candidates can be dispensed with even before the termination of the project without any notice if, his/her service is no more required or his/her contribution is considered not up to the mark.
- xi) 'No Objection Certificate' from the employer in case he/she is employed elsewhere.
